

# Historic Resources

- **Mayhew Chapel roof and window repair:** Approved \$10,000 in 2016; project In progress.
- **Martha's Vineyard Camp Meeting Association-Chair and Benches restoration:** Approved \$30,000 in 2016; Project completed.
- **Town Hall Renovation, debt service on bond issue:** Approved \$500,000 in 2008, with \$100,000 to be expended annually beginning in 2009 and completed in 2010.
- **First Congregational Church of West Tisbury:** Engineering and architectural studies to prepare for historic preservation and restoration work: Approved \$30,000 in 2009, completed in 2011: Approved \$150,000 toward preservation of the church's structural integrity in 2010; completed in 2013. Project completed.
- **Cemetery Records:** Collect and organize records for the town's cemeteries: Approved \$10,000 in 2009; in progress. Deadline for completion moved to 12/31/14 per Board of Selectmen vote on June 25, 2014. Project completed.
- **Replacement of windows in historic Dukes County Courthouse:** Approved \$8,150 in 2010; Project completed.
- **Historic Resources Inventory,** to develop a comprehensive database of the town's historic resources. Supported by CPA administrative funds: \$5,700 in 2007, 13,000 in 2008 and 13,000 in 2009; project completed in 2010.

## Cemetery Records



- **Martha's Vineyard Museum:** Approved \$27,038 in 2012 to catalog and preserve historic material in the collection of the Martha's Vineyard Museum. Project completed.
- **Town Hall Records Preservation:** Approved \$5,250 in 2012; in progress, \$5,000 in 2013. Project completed.
- **West Tisbury Cemetery Fence Replacement:** Approved \$75,000 in 2014; Project cancelled.
- **Old Mill Repairs:** Approved \$30,000 in 2014 to replace roof and install new door; Project will start in the fall of 2014. Project completed.
- **Old Mill Doors:** Approved \$20,000 in 2018 to replace the exterior doors. Project completed.
- **Martha's Vineyard Agricultural Society:** Approved \$15,000 in 2018 to replace the barn doors at the Agricultural Hall. Project completed.
- **Martha's Vineyard Museum:** Approved \$50,000 in 2018 to restore the Mayhew Peddler's Wagon as part of the permanent Museum collection. Project completed.
- **West Tisbury Congregational Church Accessibility Plan:** Approved \$45,000 in 2019 to improve code compliant accessibility and commercial kitchen facilities for the services this historic church building provides to the community. Project in progress.
- **Martha's Vineyard Camp Meeting Association, Tabernacle Roof Project:** Approved in 2020 for \$110,000 to fund the West Tisbury portion of the total regional project to replace the Martha's Vineyard Camp Meeting Association tabernacle roof.
- **Martha's Vineyard Camp Meeting Association:** Approved \$110,000 in 2021 for West Tisbury's share toward replacement of the Tabernacle roof.
- **Martha's Vineyard Camp Meeting Association:** Approved \$105,850 in 2022 for West Tisbury's share toward replacement of the Tabernacle roof.
- **Martha's Vineyard Garden Club, Old Mill Building:** Approved in 2021 for \$20,000 to fund a feasibility study of the structural integrity of the Martha's Vineyard Garden Club Old Mill building.
- **Vineyard Preservation Trust, Grange Hall Roof:** Approved in 2023 for \$235,000 for West Tisbury's share of the regional project of replacing the roof on the Grange Hall building.
- **Martha's Vineyard Garden Club:** Approved \$10,000 in 2024 for Old Mill safety improvements.
- **Vineyard Preservation Trust:** Approved \$60,000 in 2024 for Grange Hall foundation repairs
